PUPIL PREMIUM



Dear Parent/Carer,

If your child is eligible for 'free school meals' and you register them for this, we'll receive <u>extra funding</u> called 'pupil premium'. We use this extra money to improve the educational provision and resources at the school.

What is pupil premium funding?

Pupil premium funding from the government is given to schools to help pupils reach their full potential, regardless of their background or financial situation. It's provided for pupils who:

- Are registered for free school meals
- Have been registered for free school meals at any point in the past 6 years
- Are, or have been, in care
- Have parents in the armed forces

At St Peter's we get an extra £1,345 (this figure is for the 2021/2022 financial year) for every eligible pupil who is registered for free school meals. This extra money could make a real difference to the quality of education we offer. For example, we've previously used pupil premium funding for:

- Educational provision/resources
- Provision of academic interventions
- Wellbeing and self-esteem building interventions
- Increased opportunities for outdoor learning
- Funding for ELSA support

Is my child eligible for free school meals?

Your child might be eligible if you access:

- Income Support
- Income-based Jobseeker's Allowance or Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit & have an annual gross income of no more than £16,190)
- Working Tax Credit run-on
- Universal Credit (provided you have an annual net earned income not exceeding £7,400 (£616.67 p. month))

Universal infant free school meals

Currently, pupils in reception, year 1 and year 2 are all entitled to a free school meal thanks to a different government funding scheme known as universal infant free school meals (UIFSM). You shouldn't confuse UIFSM with free schools meals and the pupil premium. If your child is in reception, year 1 or year 2 and is eligible for free school meals according to the criteria above, you should still register because we'll receive the extra pupil premium funding.

Does my child have to eat the free school meals?

No. Pupils who are registered for free school meals don't have to eat them. If you're eligible but you want your child to have packed lunches you should still register because the school will receive the funding which can support your child in other ways.

How do I register?

You only need to register once at the school.

To register, please return the complete the registration form overleaf to the school office (hard copies of this form can be obtained from the school office). Even if you are not sure if you will be eligible, it is worth filling in the form as once we have the details we can easily check for you.
